# 1. Introduction

Our website, <u>http://marszpa.cluster030.hosting.ovh.net/kanban</u> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). # 2. What are cookies?

# 3. What are scripts?

A script is a piece of program code that is used to make our website function properly and interactively. This code is executed on our server or on your device.

### 4. What is a web beacon?

### 5.1 Technical or functional cookies
